1. The **Bhimeshwor Municipality, Office of the Municipal Executive** invites *electronic* bids from eligible bidders for the procurement of ***Supply and Installation of CCTV Camera at Market Area and Ward Offices under*** National competitive bidding – Single Stage Two Envelope procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document of Rs. 3000/- in the following Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at Bhimeshwor Municipality on Friday, June 7, 2024, 13:00 PM
6. Electronic bids must be submitted to the office Bhimeshwor Municipality, Charikot, Dolakha through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 PM on 18<sup>th</sup> June, 2024. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **18<sup>th</sup> June, 2024, 13:00 PM** at the office of ***Bhimeshwor Municipality, Charikot, Dolakha***. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
