Bhimeshwar Municipality, Office of the Municipal Executives has allocated funds for **Gaurishankar Bahumukhi Campus Bhawan Nirman** and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwar Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of **Gaurishankar Bahumukhi Campus Bhawan Nirman** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs. 20 Million]**
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing **at least One RCC Framed Structured Building** within the **last 5 (Five) years**, with a value of at least **NRs 16 Million**.
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 16 MT Reinforcement works**.
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 80 cum. of M20 RCC Works**.
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 84 cum. of Brick Masonary Works**.

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1<sup>st</sup> April, 2022, 14:00 PM** at the office of **Bhimeshwar Municipality**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a **NRs. 5,50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
