Bhimeshwor Municipality, Office of the Municipal Executives has allocated funds for the **Construction of Campus Building** and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

1. **Bhimeshwor Municipality, Office of the Municipal Executives** invites electronic bids from eligible bidders for the construction of **Gaurishankar Bahumukhi Campus Bhawan Nirman** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: **[NRs. 32 Million]**
 - Participation as Prime contractor in at least **One Government Building with RCC framed structure having total floor area 3000 Sq. ft. within the last 5 (Five) years**, with a value of at least **NRs 18 Million**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 33 MT Reinforcement works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 210 cum. of Concrete Works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building with 101 cum. of Brick Works**

An eligible bidder wishing to e-bid are supposed to submit a copy of payment of a nonrefundable fee of **NRs. 5,000.00** within 30 days from publication of notice in the following details and the bidders should submit copy of company/firm registration certificate, tax clearance certificate of previous fiscal year.

4. Pre-bid meeting shall be held at **Bhimeshwor Municipality at 18th January, 2021, 14:00 PM**
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **28th January, 2021, 14:00 PM** at the office of **Bhimeshwor Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a **NRs. 600,000.00** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
