Invitation for Bids for the BMP/NCB/WORKS/2079-080/E/02 Date of publication: 5th September, 2022

Bhimeshwor Municipality, Office of the Municipal Executives has allocated funds for **Mahankal Marga (Anathalaya- Mahankal Road)** and intends to apply eligible bidders for the same. Bidding is open to all eligible as per Section V of bidding document.

 Bhimeshwor Municipality, Office of the Municipal Executives invites electronic bids from eligible bidders for the construction of Mahankal Marga (Anathalaya- Mahankal Road) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs. 38 Million]
- At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing at least One Road within the last 10 (Ten) years, with a value of at least NRs 10300 Thousand.
- At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a Road with 530 CUM RCC 1:2:4 works.
- At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a Road with 30 MT Reinforcement works.

- 5. Electronic bids must be submitted to the office Bhimeshwor Municipality, Charikot, Dolakha through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **10**th *October*, **2022**, **12:00 PM**. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 10th October, 2022, 13:00 PM at the office of Bhimeshwor Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid\amounting to a NRs. 7,00,000.00 which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. Matters not covered by this Notice shall be according with the Public Procurement Act 2063 and Public Procurement Regulation 2064.
